Athletic Waiver & Release of Responsibility

NOTE: THIS RELEASE OF LIABILITY AND WAIVER AGREEMENT MUST BE READ AND SIGNED BEFORE THE PARTICIPANT IS PERMITTED TO TAKE PART IN THE 2011-2012 PLYOUTH WAYZATA SPEEDSKATING FALL/WINTER SEASON AT THE PLYMOUTH ICE CENTER, PLYMOUTH, MN BY SIGNING THIS AGREEMENT, THE PARTICIPANT AFFIRMS HAVING READ IT.

In consideration of my involvement in the sport and activities under the auspices of U.S. Speedskating, I acknowledge, appreciate and agree that:

- 1. I risk bodily injury, including paralysis, dismemberment, disability and death**, and while particular rules of my sport, equipment, and personal training and discipline may reduce this risk, this risk of injury does exist, as well as the risk to damage to or loss of property;
- 2. I knowingly and freely assume all such risks**, both known and unknown, **even if arising from the negligence of the releasees or others**;
3. I willingly agree to comply with the stated and customary terms and conditions for participation. If however, I observe any unusual or unnecessary hazard during my presence or participation, I will bring such to the attention of the coach, club officials or the city, and refuse to use the unsafe facility or equipment. I will provide all personal equipment and protective devices and well maintain and keep such equipment and items in proper condition.
- 4. I, for myself, and on behalf of my heirs, assigns, personal representatives and next of kin, hereby release, hold harmless and promise not to sue U.S. Speedskating, the Greater Minnesota Speedskating Association, Plymouth Wayzata Speedskating Club (PWSS), PWSS Officers/Board Members, the Plymouth Ice Center, the city of Plymouth, the International Olympic Committee, the United States Olympic Committee, the International Skating Union or other sponsoring organizations, their officers, volunteers, staff, sponsors and/or agents (*releasees") with respect to any and all injury and loss arising from my participation, whether caused by the negligence of the releasees or otherwise, except that which is the result of gross negligence or wanton misconduct.**
